

AN ACT

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend, on a temporary basis, the Day Care Policy Act of 1979 to establish a pilot community-based Quality Improvement Network that will allow children and families to benefit from early, continuous, intensive, and comprehensive child development and family-support engagement services, including educational, health, nutritional, behavioral, and family support services.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the “Early Learning Quality Improvement Network Temporary Amendment Act of 2015”.

Sec. 2. The Day Care Policy Act of 1979, effective September 19, 1979 (D.C. Law 3-16; D.C. Official Code § 4-401 *et seq.*), is amended by adding a new section 15a to read as follows:

“Sec. 15a. Comprehensive child development programs.

“(a) Notwithstanding sections 3 through 11, the Office of the State Superintendent of Education (“OSSE”) shall establish a pilot community-based Quality Improvement Network (“QIN”) composed of:

“(1) Child development hubs, selected through a competitive process, that will provide quality improvement technical assistance and comprehensive services to licensed child development centers and licensed child development homes selected by OSSE to be partners and that agree to meet federal Early Head Start Program Performance Standards for program participation; and

1 “(2) Child development centers and child development homes, selected through a
2 competitive process, to provide low-income infants and toddlers high-quality, full-day, full-year
3 comprehensive early learning and development services and continuum of care.

4 “(b) Child development centers and child development homes within the QIN shall
5 receive technical assistance from child development hubs to achieve the following within 18
6 months of being selected by OSSE to participate in the QIN:

7 “(1) Child development centers and child development homes within the QIN
8 shall have adult-to-child ratios and group sizes that meet or exceed federal Early Head Start
9 standards for all children from birth to 3 years of age in child development centers, or as
10 otherwise approved by OSSE.

11 “(2) Child development centers and child development homes within the QIN
12 shall have a comprehensive curriculum or program that is aligned with federal Head Start
13 Program Performance Standards and the District’s early learning and development standards for
14 serving infants, toddlers, and their families.

15 “(3) Staff who have direct supervision of infants and toddlers at child
16 development centers and child development homes within the QIN shall, at a minimum, meet or
17 exceed Early Head Start Standards for staff qualifications or credentials.

18 “(4) Child development centers and child development homes within the QIN
19 shall partner with child development hubs to develop and implement a quality improvement plan,
20 including aligning program policies and procedures to support on-site coaching, professional
21 development, and teacher planning time.

22 “(5) Child development centers and child development homes within the QIN
23 shall provide child-, family-, and program-level data to OSSE and the child development hubs as
24 requested.

1 “(6) Child development centers and child development homes within the QIN
2 shall participate in ongoing, on-site, and desktop monitoring activities to ensure compliance with
3 program requirements and Head Start Program Performance Standards required to remain in
4 good standing with OSSE, the child development hubs, and the U.S. Department of Health and
5 Human Services, Office of Head Start, if applicable.

6 “(7) Child development centers and child development homes within the QIN
7 shall support comprehensive services for children and families by the child development hubs,
8 including implementation of individualized family service plans.

9 “(8) Child development centers and child development homes within the QIN
10 shall participate in the Child and Adult Care Food Program.

11 “(9) Child development centers and child development homes within the QIN
12 shall facilitate children’s and families’ transitions to Pre-K or Head Start programs.

13 “(c) OSSE shall have authority to set payment rates, and to develop policies and
14 procedures for high-quality early learning and development services set under the authority of
15 this section.

16 “(d) To be eligible for infant and toddler child development services provided by child-
17 care partners in the QIN, a child shall be a resident of the District of Columbia and between birth
18 and 3 years of age; provided, that a child who turns 3 years old during a program year may
19 continue to receive services for the duration of the program year before transitioning into a pre-
20 kindergarten or Head Start preschool program.

21 “(e) To the extent possible, priority enrollment shall be given to children between birth
22 and 3 years of age whose families are living at or below the federal poverty level, who are
23 homeless or in the foster care system, or who live with a grandparent, godparent or relative who
24 is receiving a grandparent caregiver subsidy pursuant to Title I of the Grandparent Caregivers

1 Pilot Program Establishment Act of 2005, effective March 8, 2006 (D.C. Law 16-69; D.C.
2 Official Code § 4-251.01 *et seq.*).

3 “(f) OSSE shall monitor the child development hubs and partner participants in the QIN
4 for adherence to policies and procedures set under the authority of this act.

5 “(g) OSSE may, in whole or in part, terminate the grant provided to a child development
6 hub or partner participant at any time if OSSE determines that the hub or partner participant has:

7 “(1) Substantially failed to comply with, or meet the objectives and terms of, the
8 grant award; or

9 “(2) Failed to comply with applicable federal or District laws or regulations.

10 “(h) OSSE shall continue on-site monitoring for health and safety licensing compliance
11 of child-care partners participating in the QIN; provided, that OSSE may delegate to the child
12 development hubs on-site monitoring of the compliance of participating child development
13 centers and homes with federal Head Start Program Performance Standards; provided, that
14 relevant data collected by child development hubs is regularly reported to OSSE.”.

15 Sec. 3. Fiscal impact statement.

16 The Council adopts the fiscal impact statement of the Chief Financial Officer as the fiscal
17 impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act,
18 approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(3)).

19 Sec. 4. Effective date.

20 (a) This act shall take effect following approval by the Mayor (or in the event of veto by
21 the Mayor, action by the Council to override the veto), a 30-day period of congressional review
22 as provided in section 602(c)(1) of the District of Columbia Home Rule Act, approved December
23 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
24 Columbia Register.

1 (b) This act shall expire after 225 days of its having taken effect.
