6 IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

9 To adjust, on a temporary basis, certain allocations requested in the Fiscal Year 2015
10 Budget Request Act pursuant to section 446 of the District of Columbia Home Rule
11 Act.

13 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,
14 That this act may be cited as the "Fiscal Year 2015 Budget Adjustment Temporary Act of
15 2014".
16

17 Sec. 2. Pursuant to section 446 of the District of Columbia Home Rule Act,
18 approved December 24, 1973 (87 Stat. 801; D.C. Official Code § 1-204.46), the fiscal
19 year 2015 budgets for the following agencies shall be adjusted by the following amounts:

21 **TITLE II—DISTRICT OF COLUMBIA FUNDS—SUMMARY OF EXPENSES**
22

23 \$32,408,000 (of which \$32,408,000 shall be added to local funds) to be allocated
24 as follows:
25

26 **Government Direction and Support**

27 The appropriation for Government Direction and Support is increased by \$600,000
28 in local funds; to be allocated as follows:

29 (1) Office of the District of Columbia Auditor. - \$600,000 is added to be
30 available from local funds.
31

32 **Economic Development and Regulation**

33 The appropriation for Economic Development and Regulation is increased by
34 \$31,808,000 in local funds; to be allocated as follows:

35 (1) Office of the Deputy Mayor for Planning and Economic Development. -
36 \$31,808,000 is added to be available from local funds provided, that all funds deposited
37 into the Soccer Stadium Financing Fund are, without regard to fiscal year, authorized for
38 expenditure and shall remain available until expended.

40 **Capital Outlay**

41 The appropriation for capital construction projects is increased by \$139,206,561.

43 Sec. 3. Fiscal impact statement.

44 The Council adopts the fiscal impact statement of the Office of the Chief Financial
45 Officer as the fiscal impact statement required by section 602(c)(3) of the District of

4 Sec. 4. Effective date.

5 (a) This act shall take effect following approval by the Mayor (or in the event of
6 veto by the Mayor, action by the Council to override the veto), a 30-day period of
7 Congressional review as provided in section 602(c)(1) of the District of Columbia Home
8 Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-
9 206.02(c)(1)), and publication in the District of Columbia Register.

10 (b) This act shall expire after 225 days of its having taken effect.
