Dear Chairman Mendelson:

Enclosed for consideration and approval by the Council of the District of Columbia is a proposed emergency act, the "Purchase Orders to Human Care Provider Agreement RM-14-HCPA-051-BY4-CPS Approval and Payment Authorization Emergency Act of 2014", along with an emergency declaration resolution, to approve Purchase Orders PO461297, PO461297-V2, PO485974, PO485974-V2 and PO485974-V3 totaling \$1,101,375.55 to Human Care Provider Agreement No. RM-14-HCPA-051-BY4-CPS between the Department of Behavioral Health and Clean and Sober Streets for Level I Narcotic/Opioid Outpatient Substance Abuse Treatment services to eligible District residents.

Along with the emergency legislation, I am forwarding a contract summary and certifications of legal sufficiency, funding availability and tax compliance. The Human Care Provider Agreement expenditures in excess of one million Dollars allowed Clean and Sober Streets to provide continuity of services to meet Public Health and Welfare requirements for Level III Non Hospital Residential Substance Abuse Treatment Services to those who are eligible for care under the Choice in Drug Treatment Act of 2000, effective July 8, 2000 (D.C. Law 13-146, D.C. Official Code §7-3001 *et seq.*)

14 To declare the existence of an emergency with respect to the need to approve that Purchase  
15 Orders PO461297, PO461297-V2, PO485974, PO485974-V2 and PO485974-V3 to  
16 Human Care Provider Agreement No. RM-14-HCPA-051-BY4-CPS (formerly known as  
17 APHC-2013-E-0004) between the Department of Behavioral Health and Clean and Sober  
18 Streets, Inc., to authorize payment for the services received under the Agreement.

21 RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this  
22 resolution may be cited as the “Purchase Orders to Human Care Provider Agreement No. RM-  
23 14-HCPA-051-BY4-CPS Approval and Payment Authorization Emergency Declaration  
24 Resolution of 2014”.

25 Sec. 2. (a) There exists an immediate need to approve Purchase Orders PO461297,  
26 PO461297-V2, PO485974, PO485974-V2 and PO485974-V3 totaling \$1,101,375.55 to Human  
27 Care Provider Agreement No. RM-14-HCPA-051-BY4-CPS (formerly known as APHC-2013-E-  
28 0004) between the Department of Behavioral Health and Clean and Sober Streets, Inc., for Level  
29 III non-hospital residential substance abuse treatment services to eligible District residents.

30 (b) Due to higher than anticipated utilization and to maintain continuity of care, the cost  
31 of the Human Care Provider Agreement No. RM-14-HCPA-051-BY4-CPS for the period from  
32 May 2, 2013 through May 1, 2014 was \$1,101,375.55.

33 (c) Council approval is necessary since the purchase orders issued under the Human Care  
34 Provider Agreement exceed the \$1,000,000 threshold during a 12-month period.

35 (d) Without this approval, Clean and Sober Streets, Inc., cannot be paid for services  
36 provided in excess of \$1,000,000 for the period May 2, 2013 through May 1, 2014.

37 Sec. 3. The Council of the District of Columbia determines that the circumstances  
38 enumerated in section 2 constitute emergency circumstances making it necessary that the  
39 “Purchase Orders to Human Care Provider Agreement No. RM-14-HCPA-051-BY4-CPS  
40 Approval and Payment Authorization Emergency Declaration Resolution of 2014” be adopted  
41 after a single reading.

42 Sec. 4. This resolution shall take effect immediately.
