A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification Nos. 1, 2, and 3 and proposed Modification No. 4 to Contract No. GAGA-2016-C-0028 with Vision Security Solutions, LLC to procure monitoring, maintenance, repair and replacement services for closed circuit television cameras deployed at the District of Columbia Public Schools' sites during option year one, and to authorize payment for the services received and to be received under these modifications.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the "Modifications to Contract No. GAGA-2016-C-0028 with Vision Security Solutions, LLC Approval and Payment Authorization Emergency Declaration Resolution of 2017".

Sec. 2(a) There exists a need to approve Modification Nos.1, 2 and 3 and proposed Modification No. 4 to Contract No. GAGA-2016-C-0028 with Vision Security Solutions, LLC to procure monitoring, maintenance, repair and replacement services for the closed circuit television cameras deployed at District of Columbia Public School sites and to authorize payment for the goods and services received and to be received under Modification Nos. 1, 2, 3 and proposed Modification No. 4.

1 (b) By Modification No. 1, on December 23, 2016, the District of Columbia
2 Public Schools exercised a partial option for option year one in the amount of
3 \$207,343.16 for the period from January 1, 2017 through February 28, 2017.

4 (c) By Modification No. 2, on February 16, 2017, the District of Columbia Public
5 Schools exercised a second partial option in the amount of \$353,665.42 for the period
6 from March 1, 2017 through June 15, 2017.

7 (d) By Modification No. 3, on June 2, 2017, the District of Columbia Public
8 Schools exercised a third partial option in the amount of \$308,010, resulting in a total
9 not-to-exceed amount of \$869,018.58 for the period from January 1, 2017 through
10 August 15, 2017.

11 (e) Modification No. 4 is now necessary to increase the not-to-exceed amount by
12 \$375,040.42, resulting in a total not-to-exceed amount for option year one of \$1,244,059
13 for the period from January 1, 2017 through December 31, 2017.

14 (f) Council approval is necessary since these modifications increase the contract
15 by more than \$1 million during a 12-month period.

16 (g) Approval is necessary to allow the continuation of these vital services.
17 Without this approval, Vision Security Solutions, LLC cannot be paid for goods and
18 services provided in excess of \$1 million for the contract period from January 1, 2017
19 through December 31, 2017.

20 Sec. 3. The Council of the District of Columbia determines that the
21 circumstances enumerated in section 2 constitute emergency circumstances making it
22 necessary that the “Modifications to Contract No. GAGA-2016-C-0028 with Vision

- 1 Security Solutions, LLC Approval and Payment Authorization Emergency Act of 2017”
- 2 be adopted after a single reading.
