23	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
24	this resolution may be cited as the "Washington Metropolitan Area Transit Authority
25	Adult Learners Transit Benefits Enrollment Agreement Approval and Payment
26	Authorization Emergency Declaration Resolution of 2018".
27	Sec. 2. (a) There exists an immediate need to approve Modification #1 to an
28	Enrollment Agreement (Agreement) with the Washington Metropolitan Area Transit
29	Authority (WMATA) to provide adult learners enrolled in qualified programs transit
30	benefits to get to and from their learning centers.
31	(b) On December 21, 2017, the District Department of Transportation entered
32	into an Agreement with WMATA for Nine Hundred Ninety Nine Thousand Nine
33	Hundred and Ninety-Nine Dollars (\$999,999) to cover adult learners transit subsidies for
34	January, February, March and April.

1	(c) Modification #1 to that Agreement will add Nine Hundred Eighty-Eight
2	Thousand and One Dollar (\$988,001) to the Agreement to cover adult learners transit
3	subsidies for the rest of Fiscal Year 2018.
4	(d) The total amount to the District for this Agreement is One Million, Nine
5	Hundred Eighty-Eight Thousand Dollars (\$1,988,000).
6	(e) Council approval is necessary since this agreement is in excess of \$1,000,000
7	during a 12-month period.
8	(f) Council authorized the Mayor to spend up to One Million, Nine Hundred
9	Eighty-Eight Thousand Dollars (\$1,988,000) on a program for students of adult learning
10	programs to receive subsidies for the Metrorail and Metrobus Transit Systems in section
11	7122 of the Fiscal Year 2018 Budget Support Act of 2017, effective December 13, 2017
12	(D.C. Law 22-33; 64 DCR 7652).
13	(g) Furthermore, Council approval is necessary to allow the District to continue
14	to provide adult learners vital services of transit subsidies to ride Metrorail and Metrobus
15	Transit Systems to and from their learning centers.
