

A BILL

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To amend, on a temporary basis, the Health Services Planning Program Re-Establishment Act of 1996 to set forth the maximum fee for filing a Certificate of Need application by Unity Health Care, Inc. for a project located at 4430 Benning Road, NE, Washington D.C. 20019.

BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this act may be cited as the “Unity Health Care, Inc. Certificate of Need Maximum Fee Establishment Temporary Amendment Act of 2017.”

Sec. 2. Section 21 of the Health Services Planning Program Re-Establishment Act of 1996, effective April 9, 1997 (D.C. Law 11-191; D.C. Official Code § 44-420), is amended by adding a new subsection (c) to read as follows:

“(c)(1) Notwithstanding the provisions of subsection (a) of this section, the maximum application fee that may be collected from Unity Health Care, Inc. shall be \$5,000 for a project located at 4430 Benning Road, NE, Washington D.C. 20019”.

Sec. 3. Fiscal impact statement.

36 (a) This act shall take effect following approval by the Mayor, (or in the event of veto by
37 the Mayor, action by the Council of the District of Columbia to override the veto), a 30-day
38 period of Congressional review as provided in section 602(c)(1) of the District of Columbia
39 Home Rule Act, approved December 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206(c)(1)),
40 and publication in the District of Columbia Register.

41 (b) This act shall expire after 225 days of its having taken effect.
