A PROPOSED RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve Modification Nos. 6, 7, 7-A, 7-B, 8, 8-A and 9 to Contract No. RM-14-RFP-200-SIL-CCI-BY4-SC with Community Connections, Inc. to provide supported independent living services and to authorize payment for the goods and services received and to be received under that contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this resolution may be cited as the “Modifications to Contract No. RM-14-RFP-200-SIL-CCI-BY4-SC with Community Connections, Inc. Approval and Payment Authorization Emergency Declaration Resolution of 2017”.

Sec. 2. (a) There exists a need to approve Modification Nos. 6, 7, 7-A, 7-B, 8, 8-A and 9 to Contract No. RM-14-RFP-200-SIL-CCI-BY4-SC with Community Connections, Inc. to provide supported independent living services and to authorize payment for the goods and services received and to be received under Modification Nos. 6, 7, 7-A, 7-B, 8, 8-A and 9.

(b) By Modification No. 6, the Office of Contracting and Procurement (“OCP”), on behalf of the Department of Behavioral Health, exercised a partial option of option

1 year three of Contract No. RM-14-RFP-200-SIL-CCI-BY4-SC for the period from March
2 1, 2017 through September 30, 2017 in the amount of \$707,805.

3 (c) Modification No. 7 was an administrative modification.

4 (d) Modification No. 7-A was an administrative modification.

5 (e) Modification No. 7-B was an administrative modification.

6 (f) Modification No. 8 exercised another partial option of option year three of
7 Contract No. RM-14-RFP-200-SIL-CCI-BY4-SC for the period from October 1, 2017
8 through December 15, 2017 to the total amount of \$959,175.

9 (g) Modification No. 8-A exercised another partial option of option year three of
10 December 16, 2017 through January 15, 2018 at no additional cost.

11 (h) Modification No. 9 is now necessary to exercise the remainder of option year
12 three in the total amount of \$1,300,000.

13 (i) Council approval is necessary since these modifications increase the contract
14 by more than \$1 million during a 12-month period.

15 (j) Approval is necessary to allow the continuation of these vital services.

16 Without this approval, Community Connections, Inc. cannot be paid for goods and
17 services provided in excess of \$1 million for the contract period March 1, 2017 through
18 February 28, 2018.

19 Sec. 3. The Council of the District of Columbia determines that the
20 circumstances enumerated in section 2 constitute emergency circumstances making it
21 necessary that the Modifications to Contract No. RM-14-RFP-200-SIL-CCI-BY4-SC
22 with Community Connections, Inc. Approval and Payment Authorization Emergency Act
23 of 2017 be adopted after a single reading.

1 Sec. 4. This resolution shall take effect immediately.
