18 To amend, on a temporary basis, Title 1 of the District of Columbia Education Research Practice
19 Partnership Establishment and Audit Act of 2018, to make technical and clarifying
20 changes.
21

22 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That this
23 act may be cited as the “Education Research Practice Partnership Technical Temporary
24 Amendment Act of 2019”.

25 Sec. 2. Title 1 of the District of Columbia Education Research Practice Partnership
26 Establishment and Audit Act of 2018, effective March 28, 2019 (D.C. Law 22-268; D.C.
27 Official Code § 38-785.01 *et seq.*) is amended as follows:

28 (a) Section 104(b) (D.C. Official Code § 38-785.03(b)) is amended to read as follows:

29 “(b)(1) Prior to issuance of the Notice, the Mayor shall transmit to the Council a proposed
30 resolution to approve the proposed Notice for a 45-day period of Council review, excluding
31 Saturdays, Sundays, legal holidays, and days of Council recess.

32 “(2) If the Council does not approve the proposed Notice within this 45-day
33 review period, the proposed resolution shall be deemed disapproved.

34 “(3) If the Council disapproves the proposed resolution, the Council may include

35 recommendations for revisions that should be made to the Notice before it is re-transmitted to the
36 Council for approval.

37 “(4) Once the Notice is approved by the Council, the Mayor shall issue it within
38 30 days. The final Notice issued by the Mayor shall be substantially similar to the proposed
39 Notice approved by the Council.”.

40 (b) Section 105 (a)(3) (D.C. Official Code § 38-785.04(a)(3)) is amended by striking the
41 phrases “educational improvement” and “education improvement” and inserting the phrase
42 “school improvement” in their place.

43 (c) Section 106 (D.C. Official Code § 38-785.05) is amended as follows:

44 (1) Subsection (c)(2) (D.C. Official Code § 38-785.05(c)(2)) is amended by striking
45 the phrase “final research findings by the Partnership” and inserting the phrase “research
46 findings by the Partnership” in its place.

47 (2) Subsection (d)(1)(A) is amended by striking the phrase “of receiving Advisory
48 committee feedback”.

49 Sec. 3. Fiscal impact statement.

50 The Council adopts the fiscal impact statement of the Chief Financial Officer as the fiscal
51 impact statement required by section 602(c)(3) of the District of Columbia Home Rule Act,
52 approved December 24, 1973 (87 Stat. 813; D.C. Official Code §1-206.02(c)(3)).

53 Sec. 4. Effective date.

54 (a) This act shall take effect following approval by the Mayor (or in the event of veto by
55 the Mayor action by the Council to override the veto), a 30-day period of Congressional review as
56 provided in Section 602(c)(1) of the District of Columbia Home Rule Act, approved December

57 24, 1973 (87 Stat. 813; D.C. Official Code § 1-206.02(c)(1)), and publication in the District of
58 Columbia Register.

59 (b) This act shall expire after 225 days of its having taken effect.
