Dear Steve:

Pursuant to your request, we are providing you with a breakdown of the payments made to Jack Evans by Manatt, Phelps & Phillips, LLP ("Manatt") while he was employed at Manatt from October 5, 2015 until November 17, 2017.

As stated in our August 23, 2019 letter and Evans' employment agreement with Manatt, Jack Evans received a base compensation of \$5,000.00 per month, payable on the Firm's regular semi-monthly payroll schedule. Although Jack Evans was entitled to an additional sum equal to the amount by which 25% of his collections on his personal work effort plus 10% of his Source Collections exceeds \$60,000 and was eligible to receive a discretionary bonus for each calendar year, none was paid to him.
