17 To approve, on an emergency basis, Modification Nos. 1 and 2 to Contract No. DCAM-  
18 20-CS-RFQ0002D, between the Department of General Services and Harvey W.  
19 Hottel, Inc., increasing the aggregate Contract amount to \$10 million, and  
20 authorizing payment to Harvey W. Hottel, Inc. for goods and services received and  
21 to be received under the modifications.

23 BE IT ENACTED BY THE COUNCIL OF THE DISTRICT OF COLUMBIA,  
24 that this act may be cited as the “Modification Nos. 1 and 2 to Contract No. DCAM-20-  
25 CS-RFQ-0002D with Harvey W. Hottel, Inc. Approval and Payment Authorization  
26 Emergency Act of 2021”.

27 Sec. 2. Pursuant to section 451 of the District of Columbia Home Rule Act,  
28 approved December 24, 1973 (87 Stat. 803; D.C. Official Code § 1-204.51), and the  
29 requirements of section 202 of the Procurement Practices Reform Act of 2010, effective  
30 April 8, 2011 (D.C. Law 18-371; D.C. Official Code § 2-352.02), the Council approves  
31 Modification Nos. 1 and 2 to Contract No. DCAM-20-CS-RFQ-0002D between the  
32 Department of General Services and Harvey W. Hottel, Inc., and, authorizes payment not  
33 to exceed \$10 million to Harvey W. Hottel, Inc. for the services received and to be  
34 received under these modifications.

1           Sec. 3. Fiscal impact statement.

2           The Council adopts the fiscal statement of the Chief Financial Officer as the fiscal  
3 impact statement required by section 4a of the General Legislative Procedures Act of  
4 1975, approved October 6, 2006 (120 Stat. 2038; D.C. Official Code § 1-301.47a).

5           Sec. 4. Effective date.

6           This act shall take effect following approval by the Mayor (or in the event of veto  
7 by the Mayor, action by the Council to override the veto), and shall remain in effect for  
8 no longer than 90 days, as provided for emergency acts of the Council of the District of  
9 Columbia in section 412(a) of the District of Columbia Home Rule Act, approved  
10 December 24, 1973 (87 Stat. 788; D.C. Official Code § 1-204.12(a)).
