The hearing will be held on **Monday, April 25, 2022 at 12:45 p.m.** via zoom video conference.

The stated purpose of **PR 24-432** is to confirm the re-appointment of Lea Crusey to the Public Charter School Board (PCSB). The stated purpose of **PR 24-578** is to confirm the appointment of Nick Rodriguez to the Public Charter School Board. The stated purpose of **PR 24-579** is to confirm the appointment of Shukurat Adamoh-Faniyan to the Public Charter School Board. The stated purpose of **PR 24-580** is to confirm the appointment of Shantelle Wright to the Public Charter School Board. The Public Charter School Board is an independent government agency of the District of Columbia led by a volunteer seven-member board. As the sole public charter school authorizer in our nation’s capital, PCSB provides oversight to public charter schools which are managed by independently run nonprofit organizations called local education agencies. The purpose of this hearing is to receive testimony from government and public witnesses as to the fitness of these nominees for reappointment to the Public Charter School Board.
